Application Procedures

1. Collection of Application Forms (No quota)

Application forms can be obtained from school in person or download from school website:

2. Return of Application Forms (300 Applications for K1-K3)(160 Applications for N1)

i. **Return Method:** Please submit the completed application form in person / by post together with the following documents required:

- ✓ a copy of the child's birth certificate
- ✓ two self-addressed stamped envelopes
- ✓ a recent photo of the applicant
- ✓ cash or a crossed cheque for Application Fee HK\$40 (made payable to Caritas Nursery School - Shatin). The application fee is non-returnable whether the application is successful or not.

ii. Return Period:

- ✓ Submit in Person : Monday to Friday 9:00p.m. to 6:00p.m. and Saturday 9:00 a.m. to 1:00p.m.
- ✓ Submit by Post : Please mark "Application for admission" on the envelope .
- ✓ Application Form and required documents should be submitted **on or before 15th September 2017** . **Fax or e-mail application will not be accepted.**

Interview Arrangement

1. The Nursery School will arrange interview for all eligible applicant.
2. Interviews will be conducted from November 2017 to December 2017. The interview schedule will be sent to all eligible applicants by post on / before October 2017 to November 2017.
3. Group interviews will be arranged. We will observe the child's behavior and interview with the parents.
4. Parents are required to accompany their child for the interview to ease the anxiety in facing a new environment.
5. Interview will be conducted in Cantonese. Please contact us at [Tel: 26917175](tel:26917175), if interpretation / translation service is required.

Admission Criteria and Factors for Consideration

1. For K1 class : the child should be at least 2 years and 8 months old when she/he is admitted in 1st September 2018.
For N1 class : the child should be at least 2 years old when she/he is admitted in 1st September 2018.
2. The number of school places available in that school year.
3. Interview performance of the child.
4. The alignment of the parents' view with our school mission and values.
5. The applicant from families in needs for whole day / long whole day edu-care service will be given due priority consideration.
6. The applicant with sibling(s) currently studying in our school will be given due priority consideration.
7. The applicant has sibling(s) of our school's graduated alumni.
8. The applicant with social needs.

As the number of school places is limited, please understand that not all applicants fulfilling the priority consideration will be guaranteed a school place. Our school has the final interpretation and decision on the factors concerned.

Announcement of Admission Results

We will inform parents of the K1 admission results 2 weeks after the interviews by post.

Registration Arrangements

1. Successful applicants: Parents should complete the registration procedures for their child from **11 to 13 January 2018** ("Centralised Registration Dates") by submitting the original of the "2018/19 Registration Certificate (RC)" to our school and paying the registration fee.
2. The registration fee for 2018/19 is HK\$ 1,570. For those admitted children, the registration fee will be deducted from the school fee in September 2018.
3. If parents cannot submit the "2018/19 RC" during registration, our school may not be able to complete registration for the child. Hence, parents are required to submit application for the Registration Certificate to EDB within the specified period (September to November 2017).
4. Should parents decide to change school after registration, please notify to us in writing. We will return the "2018/19 RC" but the registration fee will not be refunded. Upon obtaining the "2018/19 RC", our school will no longer keep the school place for the child.
5. Applicants on waiting list will be notified if there were availability after the Centralised Registration Dates.
